JURYING PROCESS

The juror will select the artworks to be shown in the exhibition from the images submitted. The juror has the sole responsibility for the selection of the artworks with no exceptions. Awards are selected from the accepted entries.

ELIGIBILITY

Open to all photographers residing in Southern California.

MEDIA

- All media is eligible (painting, photography, drawing, mixed media, sculpture, ceramics, video, and digital) with the exception of crafts and jewelry. We regret not having the proper space for these media.
- Work must have been completed within the last two years.
- Artworks cannot have been exhibited in any prior juried exhibitions at IFAC.

NOTIFICATION PROCESS

Notifications of selected and non-selected work will be VIA EMAIL. If you do not have email, call (949) 724-6889 to make other arrangements.

AWARDS

A minimum of \$1,500 total in cash awards.

PRESENTATION

Work must be ready to hang or exhibit. Works over 60 lbs. must be handled by the artist during installation and removal. The artist is responsible for providing all special or unique display props.

C D SUBMISSION Please note CD's will not be returned.

- For all work submit a CD with JPEG images. JPEG images must not exceed 900KB in size.
- CD must be titled with first and last name/ jpegs must be named with entry #. Indicate title of piece, medium and dimensions on the entry form and/or extra piece of paper. CD's will not be returned.
- One detail image per entry may be included and should be labeled as such.
- Notification of selected and non-selected works will be VIA EMAIL (please include on entry form). If you do not have email, call (949)724-6889 to make other arrangements.
- IFAC is not responsible for damaged CD's. IFAC is not responsible if CD jpeg images can not be opened on a MAC.
- Works which do not meet expectations set forth in the images may be withheld from the exhibition at the juror's discretion.

SELECTED ARTISTS: IMPORTANT!

Delivery of ARTWORK: The drop off dates for selected ARTWORKS is **Monday, November 5th from 10am to 8pm ONLY**. If work is shipped, artists must pre-pay return shipping.

Pick-up of ARTWORK: Exhibited work will be available for pick-up on Thursday, January 3rd, Friday 1/4, and Saturday 1/5, 2008 from 10am-5pm. Shipped work will be returned prepaid by the artist.

Completion of CONTRACT and LOAN FORMS:

LOAN FORMS and CONTRACT AGREEMENTS need to be filled out and sent back via mail, fax, or drop-off by the SELECTED APPLICANTS or their agent **prior to Thursday, October 25th**. ARTWORKS can not be insured and will not be eligible to be included in the exhibition unless the LOAN FORMS AND CONTRACT AGREEMENTS are filled out and signed in their entirety prior to deadline. Insurance and Liability: Every reasonable precaution will be taken to ensure protection and careful handling of work. The Irvine Fine Arts Center assumes no insurance liability for damage, theft or other loss occurring during delivery and exhibition of works. Works are insured during the run of the exhibition.

Sales: The Irvine Fine Arts Center will receive a 25% commission on any work sold during the exhibition. Please consider this in your retail pricing. Price is necessary for insurance value, even if not for sale.

Agreement: Filing of entry card shall constitute agreement with all the conditions outlined in this prospectus.

ENTRY FEE AND CARD

- A non-refundable \$12 fee per entry, whether or not artworks are accepted. Up to six entries per artist.
- Entry card, jury notification card, and CD must accompany each check.
