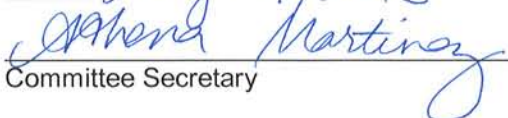
COMMUNICATION DEVICES
