#### 1. APPROVAL OF ZONING ADMINISTRATOR MINUTES

## 2. SIGN PROGRAM MODIFICATION WITH ADMINISTRATIVE RELIEF (00735107-PSS) FOR THE MARKET PLACE CENTER IN PLANNING AREA 4 (LOWER PETERS CANYON)

Katie Berg-Curtis, Kapstone, Consultant to the City, gave the staff report.

Zoning Administrator Carmichael noted that the addition of an on-site directional sign with increased symbol and letter size will allow for increased visibility of the café and is in scale given the size of the center and that the landscaping is mature though out the center.
