

EXECUTIVE SUMMARY

Irvine Community Alliance Fund (ICAF) is a nonprofit entity that receives and distributes funds, property and other resources to aid, sponsor, promote, advance and assist in the charitable provision of public parks, recreation and community services in and for the City and greater Irvine area. ICAF is operated by a Board of Directors consisting of community volunteers and City of Irvine staff representatives.

In accordance with ICAF Bylaws, the Chief Financial Officer of the organization is responsible for records of accounts and preparing the Annual Report regarding the financial condition of the organization.

ANALYSIS

In accordance with ICAF Bylaws, Article X, Section 7 (e), the Chief Financial Officer of the organization is responsible for keeping and maintaining adequate and correct books and records of accounts. ICAF Bylaws, Article XII, Section 3, specifies the requirements pertaining to the organization's Annual Report.

At the meeting, the Chief Financial Officer presents a summary report on the financial condition of the organization for the fiscal year 2018-19 with prior year comparison information for fiscal year 2017-18 (Attachment).

FINANCIAL IMPACT

The Statement of Contributions and Expenses report for FY 2018-19 and 2017-18 (Attachment), shows a decrease in contributions to \$14,007.88 from \$18,039.71. The contribution decrease of \$4,032.00 is primarily due to a Senior Services Keen Center contribution being paid direct to the City of Irvine General Fund in fiscal year ended June 30, 2019. The expenditures decrease from FY 2017-18 to 2018-19 is primarily due to the same factors as the contributions decrease.
