

## NOTICE OF PUBLIC MEETING CEQA MANUAL UPDATE INCLUDING SB 743 FOR VMT

City Council Meeting June 23, 2020 4:00 p.m.

PROJECT DESCRIPTION:

NOTICE IS HEREBY GIVEN that on June 23, 2020, at the hour of 4 p.m., or as soon thereafter as possible, the City Council of the City of Irvine will conduct a public meeting in the City Council Chamber, One Civic Center Plaza, Irvine, CA, to consider a comprehensive update to its California Environmental Quality Act (CEQA) Manual to comply with the State's updated CEQA Guidelines that became effective on December 28, 2018. In particular, the City's Traffic Impact Analysis Guidelines are being updated to address new requirements under Senate Bill (SB) 743 for analyzing transportation impacts using Vehicle Miles Traveled (VMT) for CEQA mitigation purposes. All California cities must implement VMT as their primary metric of transportation impact under CEQA by July 1, 2020. Additionally, related updates to the City's Traffic Study Guidelines are proposed. [This CEQA Manual and Traffic Study Guidelines Update is not considered a "project" under CEQA Guidelines Section 15378(b)(5).1
