### Early Experiences and Trauma February 23, 2021 from 4:00-5:00pm Anita Osborn, MA, PPS, LEP

In this opening webinar of the CIBC series, participants will learn about how excessive stress can interfere with young children's development, causing disruptions in learning and behavior. Early learning and care providers with an understanding of risks related to trauma are better-equipped to create safe environments and secure connections that will benefit all children in their care.

### Topics include:

- Early experiences and hierarchy of brain organization
- Childhood adversity and the impact of toxic stress, including Adverse Childhood Experiences (ACEs)
- Screening for trauma in young children
- Recognizing and responding to trauma-triggered behaviors

This webinar will explore how implicit bias affects our understanding and actions without our conscious awareness. Over time, transforming our perceptions allows us to actively promote equity in our conversations, interactions and daily activities.

This webinar will explore the essential role of the early learning and care workforce in responding to the risks associated with childhood adversity. Capacity building of competent and nurturing caregivers begins with honoring the hard work of being one. Participants will be offered tools and strategies embedded in a trauma- and resiliency-informed perspective to support their daily work with young children and their families.

- Brain-based responsive strategies
- Building resilience through positive childhood experiences
